

# ORDERS } CHRISTIAN COUNTY FISCAL COURT

12<sup>th</sup> Day of October 2020

The Fiscal Court in and for Christian County held a Special Called Meeting on October 12, 2020. Pursuant to Section 8(b) of Senate Bill 150, effective as of March 30, 2020, the meeting was conducted by audio teleconference due to the current state of emergency in the United States and the Commonwealth of Kentucky caused by the global COVID-19 pandemic.
