

Special Meeting - September 9, 1993

The Board of Directors of the Greenville Community Services District met in special session, pursuant to notice duly given as prescribed by law, on September 9, 1993 at 7:30 p.m. in the Town Hall of Greenville.

Call to Order: Board President Don Dunham called the meeting to order at 7:30 p.m.

Present: Directors Don Dunham, Ross Posch, Raymond Hamilton, Betty Henley and Mark Delizio. Also present were Jim Hamblin, Jim Peters, Francis Musser, Bob & Molly Brand, Supervisor Robert Meacher, Nancy Lund, Bruce McDonald, Becky Herrin (Planning Department), Taylorsville Fire Department secretary Velda Krafft, GCSD secretary Brenda Lal and Sheriff Don Stoy. There were also a number of Taylorsville residents present whose names are unavailable because they did not sign in.

Agenda Item #1: The merger of GCSD with the Taylorsville Fire Department and the Taylorsville County Service Area, henceforth known as the Indian Valley Community Services District.

- 1) This matter will be presented to the Planning Department for final approval on Tuesday, September 14, 1993.
- 2) Becky Herrin confirmed that Directors of IVCSA will be elected at large, and that the law specifies the number be five. The only way around the elected at large rule would be to apply to the State Legislature for exemption from this set procedure.
- 3) Bruce McDonald of Crescent Mills asked to be on record as being in favor of Crescent Mills being included in the newly-formed Indian Valley Community Services Dist. The Board reiterated that Crescent Mills was invited to participate, but had declined.

McDonald stated it was his belief that the majority of Crescent Mills residents would like to be involved, and the possibility of circulating a petition was discussed.

- 4) After discussion, a motion was made by Delizio for GCSD to inform the Board of Supervisors to proceed with the merger and send the appropriate paperwork to the State to finalize the matter. The motion was seconded by Posch, with Delizio, Posch, Dunham and Hamilton voting aye and Henley voting no. Motion carries.

Agenda Item #2: Volunteer day at the park, stripping depot roof in preparation for putting on the new roof was discussed.

- 1) The secretary asked for the number of volunteers that are expected, so as to prepare a lunch for them. It was agreed that someone will check on the workers and inform the secretary Saturday morning. Lunch at 12:00 p.m.

Agenda Item #3: Rescheduling of Oct. and Nov. meetings.

- 1) The secretary asked the Board to reschedule the October and November meetings from the third Wednesday evening to the third Thursday evening, for the purpose of the secretary taking a class at Feather River College.

A motion was made by Delizio, seconded by Hamilton, to accommodate the secretary. All voted aye and the motion carried.

With no further business to discuss, the meeting was adjourned at 8:45 p.m.
