RESOLUTION REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF PLUMAS TO APPROVE OF THE PROPOSED RESOLUTION OF INTENTION TO BE ADOPTED IN PROCEEDINGS FOR THE ACQUISITION AND CONSTRUCTION OF PUBLIC IMPROVEMENTS UNDER APPROPRIATE SPECIAL ASSESSMENT AND ASSESSMENT BOND ACTS, AND TO APPROVE OF THE BOUNDARY MAP OF THE ASSESSMENT DISTRICT

INDIAN VALLEY COMMUNITY SERVICES DISTRICT
Sewer System Improvements Assessment District

RESOLVED, by the Board of Directors (the "Board") of the Indian Valley Community Services District (the "District"), County of Plumas, California, that

WHEREAS, it is the intention of this Board to undertake appropriate special assessment and assessment bond proceedings for the acquisition and construction of the improvements in and for said District as described in Exhibit A attached hereto and incorporated herein by referenced;

WHEREAS, it is the intention of this Board to assess the costs of said acquisitions and improvements and the expenses incidental thereto upon an assessment district, the exterior boundaries of which are shown on a map entitled "Proposed Boundaries of Sewer System Improvement Assessment District," on file in the office of the Secretary of the Board of Directors (the "Secretary"), which indicates by a boundary line the extent of the territory included in the proposed district and which shall govern for all details as to the extent of the assessment district, to which reference is hereby made;

WHEREAS, the public interest and convenience will be served by the making of said acquisitions and improvements and the levying of said assessments; and

WHEREAS, the land to be assessed lies within unincorporated territory in the County of Plumas, State of California;

NOW, THEREFORE, IT IS ORDERED, as follows:

1. That request be, and the same is hereby, made that the form of Resolution of Intention to be adopted by the District and the map indicating by a boundary line the extent of territory included in the proposed assessment district be approved by the Board of Supervisors of the County of Plumas, State of California.

2. That the Secretary of this District be, and she is hereby, directed to file with the Clerk of the Board of Supervisors of the County of Plumas a certified copy of this resolution, together with copies of the proposed Resolution of Intention and said map.
