1. This application shall constitute a valid and binding contract. Applications are considered on a first-come, first-served basis, based upon receipt of this application. Booth assignments are made after receipt of payment. Placement/destination location of booth is not guaranteed. Leimert Park Book Village Fair (LPVBF) reserves the right to deem materials appropriate. Unacceptable material cannot be promoted, displayed or sold. LPVBF reserves the sole discretion, to refuse participation in the Event to any applicant for any or no reason.

2. To register and participate, authors may elect to purchase space in the Authors Pavilion for a fee (see below). Authors may also participate as a Panelist, Moderator, or Workshop Facilitator. If interested in serving as a panelist, please indicate your desired topics and forward background information, handouts, etc. for our review. Note, however, LPVBF reserves the sole discretion to select or reject an Author as a panelist, moderator, or workshop facilitator.

3. Author gives LPVBF or its designee's permission to use their voice, image or likeness as it appears in any photographic or audio recording in any manner, in all media, in perpetuity.

4. Author shall indemnify, defend and hold harmless LPVBF, Event Sponsors, and their employees, representatives and agents of each from claims, liabilities, costs, and charges (including attorneys' fees and costs) for injury, lost or damage to property or persons (including death) arising out of Author's activities in connection with the Festival, or any breach of representation, warranty or covenant in this agreement.

5. If for any reason the Event is canceled or rescheduled, Author's sole remedy shall be the recovery of the fees paid pursuant to this contract.
