Booth assignments are made after receipt of payment. Placement/destination location of booth is not guaranteed. Leimert Park Book Village Fair (LPVBF) reserves the right to deem materials appropriate. Unacceptable material cannot be promoted, displayed or sold. LPVBF reserves the sole discretion to refuse participation in the Event to any applicant for any or no reason.
2. To register and participate, authors may elect to purchase space in Authors Pavilion for a fee (see below). No reselling or sharing of space unless approved and authorized by representatives of LPVBF. On the title publication listed on the registration above can be sold or displayed at your space.
3. Author gives LPVBF or its designee's permission to use their voice, image or likeness as it appears in any photographic or audio recording in any manner, in all media, in perpetuity.
4. Author shall indemnify, defend and hold harmless LPVBF, Event Sponsors, and their employees, representatives and agents of each from claims, liabilities, costs, and charges (including attorneys' fees and costs) for injury, lost or damage to property or persons (including death) arising out of Author's activities in connection with the Event, or any breach of representation, warranty or covenant in this agreement.
