

Commissioner Barnes seconded the motion and the motion passed.

**ORDER OF

On the 23<sup>rd</sup> day of September 2020, be it known that the Board of Emergency Services Commissioners of Travis County Emergency Services District No. 12 ("District") hereby adopted by a majority vote of 4 in favor, 0 against, 0 Present-not voting, and 1 absent, the Districts ad valorem tax rate for the 2020 tax year as follows: Debt rate of \$0.0193 per \$100 valuation and a Maintenance and Operations rate of \$0.0807 per valuation for a total ad valorem rate of \$0.10 per \$100 valuation of the appraised property within the boundaries of the District. Per the Texas Tax Code §26.05, all taxes raised by said rate will be used to fund the maintenance, operations and outstanding debt expenditures of the District for the next year.


**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THE TAX RATE WILL EFFECTIVELY BE RAISED BY 1.2 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$3.00 per year.**
