To maintain the instrument in good condition, normal wear and tear excepted, and to pay for the repair of any damage to the instrument caused, directly or indirectly, by the student/parent(s) through neglect or in any other way. Routine maintenance and repair of the instrument due to normal wear and tear will be the responsibility of the school system. All repairs must be handled by the music, band or orchestra teacher.</p> <p>3. To allow the instrument to be inspected by the teacher at any time.</p> <p>4. To allow no person other than the student to play or use this instrument without specific permission of the music, band or orchestra teacher.</p> <p>5. To use the instrument properly and to the best of the student's ability during music classes, rehearsals and performances, regular home practice and additional instruction, if any.</p> <p>6. To pay a non-refundable rental fee for the use of this instrument for a term beginning on the date the instrument is issued as noted herein, and ending no later than the last day of the current school year.</p>
