This contract provides for up to eight (8) hours of coverage time by the photographer(s). Any time after the eight hour time limit will be charge overtime at \$70.00 per hour. Overtime fees are due when you receive your images. [Photography on the wedding day will begin at \\_\\_\\_\\_\\_.](#)

As the official photographer we reserve the right to request at any time during the event that friends, family or others refrain from taking photos. *Photos may be taken by friends and family at the reception in a manner that does not interfere with the official photographer.*

Personal Image use by the client: Event Photography will provide a photo release for the client. All publicly displayed or printed images must have the approval and release from Event Photography appropriately cited.

**Additional Charges:** [Retouching is available for an additional fee.](#) There will be an extra charge for special artwork, including touch-ups on skin and reflections in eyeglasses.

Other additional charges could include travel fees, charge for Friday weddings of \$100.00; and additional charge of \$50.00 for five bridesmaids; \$100.00 for over five bridesmaids. One USB drive with all images edited and ready to print will be provided to the bride and groom, extra USB drives will be available for \$35.00 each.

**Retainer Fee:** If your event is canceled 90 days before the scheduled date half (250.00) of your deposit will be returned. All cancelations must be in writing.

**Payments:** [Deposit of \\$500.00 is required to secure the event. The balance of \\$450.00 is due 3 weeks before the wedding.](#) Balance due date \_\_\_\_\_.

**Pricing:** All pricing at the time of contract for albums and prints is honored for six months following the wedding. Album/print orders will then be subject to current pricing at the time the order is placed.

**Limit of Liability:** In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Event Photography will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. We take the utmost care with respect to storage, transportation and processing of digital images. However, in the unlikely event that images are lost, stolen, or destroyed for reasons beyond the our control, all parties agree that the liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of images shall be a prorated amount of the package selected, based on the percentage of originals lost. There is no right to reject on the basis of style or composition. As your photographer we are not responsible for lack of/limited coverage due to weather conditions, scheduling complications or obstructing decorations. The client agrees that an entire wedding cannot be replicated or reenacted for the purpose of a reshoot.
