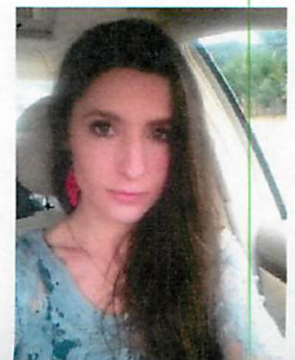
This winter is looking very good in terms of precipitation in the Indian Valley and Northeastern California. Each year, water agencies are required to report water production to the California Water Board and compare it to production in 2013. Overall, in 2016, the water users in our District did very well in conserving. The folks in Greenville saved 31.12%, while Crescent Mills saved 6.45%. We all need to maintain a conservation minded strategy going into 2017. We really appreciate the hard work you are all doing to limit water use in our valley!



Beginning January 3, 2017, the office will be open Monday – Friday from 9 a.m. to 4:30 pm. If you catch us during off hours and have a payment to make, please drop your envelope through the mail slot in the door and we will record the payment the following day. Our hope is that with these expanded hours, we can more readily assist our customers with their needs!

Speaking of payments, we want to let our customers know that if your bill becomes delinquent by \$200 (the deposit amount), you will be receiving a shutoff notice. To settle the notice, you will be required to pay your bill in full before we turn your service back on. So please, don't let your bills fall behind by the \$200 deposit amount. In addition, if you do fall behind in your payments, your deposit will not be refunded until you have one year of successful monthly payments. We also will be requiring a \$200 deposit on every new account in the District.

This month we are featuring our newest employee, Tashiauna Towers. Tash started with us in August and has been training to do meter reading and work in the office on billing and taking payments. She is a High School graduate of Plumas Charter School and attended FRC majoring in English. Tash has taken classes to be a rock-climbing instructor and loves being in the outdoors.
